

Welcome to the Halifax Transit EPass Program!

EPass holders are entitled to unlimited travel on all Halifax Transit services, which includes fixed-route, conventional bus services and Regional Express routes; ferry services; and Access-A-Bus services for those who have separately registered with HRM for such services.

EPass fees are paid through payroll deduction, at the rate of \$67.50 monthly or \$33.75 bi-weekly (1st & 2nd Pay Periods).

Conditions of Use

- The EPass Program is subject to Halifax Transit service policies and guidelines.
- Passes must be presented when boarding and are non-transferable.
- Lost, stolen, or damaged ID cards or renewal stickers are subject to a \$25 replacement fee.
- Passes do not include parking fees at Halifax Transit Park & Ride locations.
- Halifax Transit is not liable for any disruptions/interruptions in transit services.
- Passes may be confiscated if:
 - the pass is improperly used; or
 - payroll deductions are discontinued.

Suspension/Cancellation Policy

The program requires employees to enrol for **12 months**; however, passes can be either suspended or cancelled due to:

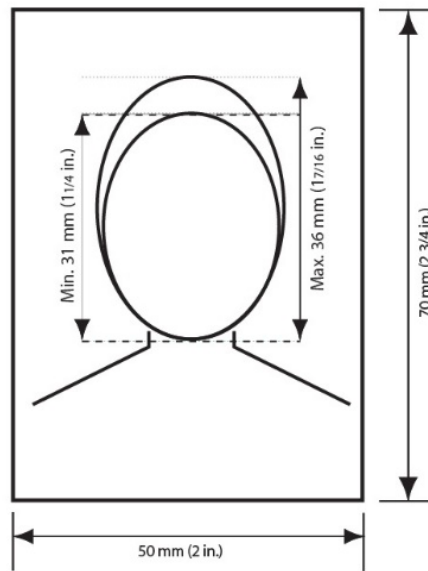
- a change in employment status;
- a change in work location or Flex Work options;
- parental leave;
- medical leave;
- any other reason acceptable to Halifax Transit, in its sole discretion.

Passes must be returned immediately upon suspension or cancellation. Payroll deductions will only be suspended when the pass is returned to the HRM SmartTrip Coordinator.

New Participants must submit a headshot photo with their application.
