The Faculty of Arts particularly encourages applications from candidates who are able to contribute to the Indigenization of the curriculum and the university. The Dean will demonstrate a deep passion for the humanities and social sciences, and will develop a bold vision aimed at implementing meaningful institutional change, prioritizing Arts and diverse peoples and knowledges. It is imperative that the new Dean be highly inclusive and collaborative in their style, and possess superb interpersonal and communication skills, and a strong orientation toward relationship building.

Nestled in the heart of Halifax, Nova Scotia, Saint Mary's has evolved into a modern, secular and metropolitan university; the second largest in the province with more than 50,000 alumni. The University is a national leader in international and intercultural education, offering a vibrant and culturally diverse environment for over 7,000 students spread across the faculties of Arts, Science, Business, Education, and Graduate Studies and Research. The University is highly ranked among Canadian universities for research; it is home to nine Canada Research Chairs and receives over \$8m annually from external funding sources. It also has a long history of athletic excellence.
